Concepts such as what it means to "carry on business in Canada", to be "resident" in Canada, or to have a "permanent establishment" in Canada will be explained. The session will also discuss how to avoid registration requirements along with the special registration requirements for publishers, ticket sellers, and others. The differences in GST/HST and Canada's income tax will also be noted. The session will also cover the Canadian Registration obligations introduced as of July 1, 2021 and the recently introduced simplified registration requirements. As part of that discussion, the speakers will provide an overview of the obligations on online marketplaces to collect Canadian indirect taxes (and corresponding relief for suppliers/vendors). The speakers will then cover your obligations if you've concluded your business must be registered for GST/HST purposes. They will provide an overview of the compliance obligations, including how and when to register, requirements to post security, maintaining your books and records outside Canada, filing and paying the tax, and reviewing the terms and conditions of your contracts to ensure compliance with invoicing requirements.

Finally, this session will provide attendees with an overview of the rules, how US companies can avoid registering for GST/HST purposes and take advantage of these rules, and discuss the changes proposed by the Canadian federal government.
