Georgia	Georgia Governor Brian Kemp (R), the IRS, and the Department of Revenue announced that certain return and payment deadlines for taxpayers have been extended for Georgians impacted by the Georgia Highway 82 Wildfire and the Pineland Road Wildfire in Clinch, Echols, and Brantley Counties. (May 8, 2026)
Hawaii	The Hawaii Department of Taxation will consider requests from taxpayers adversely affected by Hurricane Lala to waive penalties and interest for failure to timely file State returns and failure to timely pay taxes, on a case-by-case basis. Eligible taxpayers will have until October 20, 2026, to file State tax returns and make tax payments without penalties and interest. (August 20, 2026)
	The Hawaii Department of Taxation announced income tax relief for taxpayers affected by the March 2026 Kona Low weather event. (April 8, 2026)

Illinois	Illinois Governor JB Pritzker (D) and the Department of Revenue have announced disaster tax relief for individuals and businesses in 15 counties affected by widespread damage from torrential downpours, flash flooding, straight-line winds and several tornadoes. (August 20, 2026)

Michigan	In response to the state of emergency for Antrim, Cheboygan, and Emmet counties after an intense rainstorm caused widespread flooding, the Michigan Department of Treasury is offering special tax relief for affected individuals and businesses in those counties. (July 15, 2026)
	The Michigan Department of Treasury is offering relief for individuals and businesses in counties and cities impacted by prolonged rainfall, rapid snowmelt, straight-line winds, and tornadoes. (updated April 30, 2026)

	Michigan State Treasurer Rachael Eubanks states that individuals and businesses impacted by the extreme winter weather from March 15-16 are now eligible for state tax extension relief. (March 19, 2026)

Tennessee	The Tennessee Department of Revenue has advised that , consistent with the decision by the IRS to extend federal due dates to May 22 for businesses located in a designated disaster area resulting from Winter Storm Fern, it will extend the franchise and excise tax filing and payment due dates to May 22. (April 2026)
Texas	Texas Governor Greg Abbott (R) declared a disaster for Texas counties impacted by severe storms, including heavy rainfall and flash flooding. Taxpayers affected by the disaster may be eligible for an extension of time to file and pay taxes due. (July 17, 2026)
	Taxpayers affected by the recent severe storms in North Texas may be eligible for an extension of time to file and pay taxes due. (updated May 7, 2026)
